

# 2010 CUNA Management School



## Scholarship Overview

Included is the information and application for the 2010 CUNA Management School Scholarship Program. Please take the time to fill the application out completely and return it with the requested support documentation by April 15, 2010.

### Conditions of Eligibility:

- Applicants must be a credit union employee or board volunteer.
- The applicant's credit union must be affiliated with the State League or Association.
- For second and third year students – must be current with project submission guidelines, unless special consideration has been previously approved by the CMS Director.
- Should applicant status change prior to the start of school, the application may be revoked.
- The amount of the scholarship will be based on each credit union's need. The two-week school will be held at the University of Wisconsin-Madison, July 11-23, 2010.
- Scholarships, if granted, are for the current year only.

### Selection:

Applications will be reviewed, scored and ranked by the CUNA Management School Scholarship Committee. The amount of the scholarship will be based on each credit union's need.

### Award Notification:

Notification will be made in early June.

### Application Procedures:

The completed application and supporting materials must be submitted as a package and received by CUNA no later than the deadline of **April 15, 2010**.
